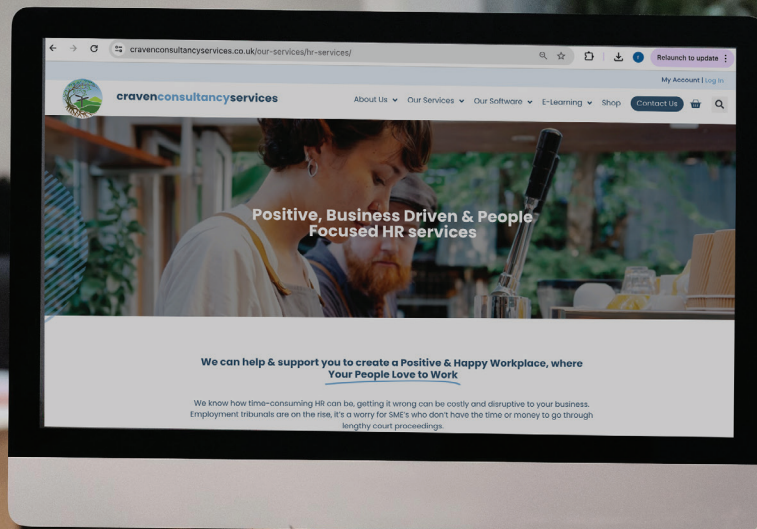

What is mandatory Health and Safety training?

Mandatory Health and Safety training is any Health and Safety training that is a legal requirement in your workplace.

For example, all workers are legally required to undertake Fire Awareness Training.

Mandatory Health and Safety training courses are essential for remaining legally compliant in any workplace.

What is statutory Health and Safety training?

Statutory training is where a statutory body has dictated that an organisation must provide training based on legislation.

What Health and Safety training is mandatory?

Mandatory Health and Safety training is broken down into two main types: **General Health and Safety Training** – All employers have a legal obligation to educate their employees in health and safety matters.

Job-specific Health and Safety Training

– This refers to work-related activities that must be carried out in accordance with the current legislation. These are specific tasks or activities, for example, the lifting of objects or working at heights. If you're unsure of which Health and Safety training you need to remain legally compliant, get in touch with a member of our team.
